



## TERMS & CONDITIONS

- Only 35,500 tickets will be sold.
- 1,035 prizes worth more than \$1.4 Million.
- 1 in 35 chances to win.
- Purchasers must be at least 19 years of age.
- Tickets must be purchased and mailed within Newfoundland and Labrador.
- Only tickets that have been verified as paid for are eligible for the respective draws.
- All ticket purchases are final and refunds are not available.

All inquiries, if any, regarding the chances of winning are to be made to the licensee prior to the purchase of the ticket(s).

All tickets in a 3-pack, 5-pack, or Super Pack, and all Add-Ons in a 3-pack, 5-pack, 6-pack or 15-pack, must contain the same information.

The official ticket serves as the purchaser's official receipt and confirms the ticket numbers that will be entered for the lottery. This is not a counterfoil-style lottery; there will be a maximum of 35,500 unique numbers eligible for all draws (based on a complete sell-out).

Only one "official ticket" issued by Deloitte LLP will be provided. Ticket numbers assigned will be sequential (i.e. all the names provided on the form will be entered in the lottery database and will match all ticket numbers assigned).

## Group Purchases

In the event a winning ticket has more than one name on it, the prize will be awarded to only the primary ticket holder identified on the ticket. # Draw Dates and Deadlines

The Bonus Prize ticket sales deadline is midnight, Friday, April 5, 2019.  
The Bonus Prize draw date is April 17, 2019.  
The Bonus Prize Winner Announcement will be made on April 17, 2019.

The Early Bird ticket sales deadline is midnight, Friday, May 3, 2019. \*  
The Early Bird draw date is May 14, 2019.  
The Early Bird Winner Announcement will air on May 16, 2019.

If required, the Final ticket sales deadline is midnight, Friday, May 17, 2019. \*\*  
The Final draw date is May 28, 2019.  
The Final Draw Winner Announcement will air on May 30, 2019.

## **TICKETS SOLD BY THE BONUS SALES DEADLINE:**

All tickets sold by midnight, Friday, April 5, 2019, would be eligible for the Bonus Prize draws on April 17, 2019. The draws would take place at the offices of Deloitte LLP, located at 5 Springdale Street, Suite 1000, St. John's, NL.

## **\*IF ALL TICKETS ARE SOLD BY THE EARLY BIRD DEADLINE:**

In the event all tickets are sold by the Early Bird cut-off of midnight, Friday, May 3, 2019, then all draws would take place on May 14, 2019, commencing at approx. 9:00 a.m. at the offices of Deloitte LLP, located at 5 Springdale Street, Suite 1000, St. John's, NL. The Early Bird Prize draw would be conducted first and followed by draws for all remaining prizes in order of retail value beginning with the prizes of least retail value.

The top valued prize draw announcement would be produced between 10:30 a.m. and noon on May 16, 2019, from the Grand Prize Showhome. The Grand Prize Showhome is located at 4 Ocean's Edge, St. Philip's. The live-to-tape announcement would air on NTV later that same day.

Title transfer for the Grand Prize Showhome would be May 27, 2019.

In the event tickets remain after the Early Bird cut-off, then only the Early Bird draw would be made on May 14, 2019, commencing at approx. 9:00 a.m. at the offices of Deloitte LLP. The announcement of the Early Bird winner would be made on NTV later that same day. Ticket sales would continue to the final sales cut-off of midnight, Friday, May 17, 2019. All remaining draws would begin on Tuesday, May 28, 2019, commencing at approx. 9:00a.m. at the offices of Deloitte, located at 5 Springdale Street, Suite 1000, St. John's, NL. Draws would proceed in order of retail value beginning with the prize of least retail value.

Production of the grand prize announcement would take place on the afternoon of May 30, 2019 and would be aired live-to-tape on NTV later that same evening.

Title transfer for the Grand Prize Showhome would be June 10, 2019.

## Draw Order

All draws are open to all eligible ticket holders. The first draws are for the Bonus Prizes, then the Early Bird Prize; then all draws are made in the order of the least retail value up to the Grand Prize as follows:

In the event all tickets are sold by the Early Bird ticket sales deadline of midnight, May 3, 2019, the 50/50 Add-On draw will be made on May 14, 2019. There will be a minimum payout of \$100,000 for the 50/50 Add-On. The 100 Days of Winning Cash Calendar Add-On draws will be made on May 14, 2019. If tickets remain after the Early Bird ticket sales deadline, the 50/50 Add-On draw and 100 Days of Winning Cash Calendar Add-On draws will be made on May 28, 2019.

There are 100 prizes in the 100 Days of Winning Cash Calendar with a total prize value of \$100,000. Winner will be posted daily on the lottery website June 15 to September 22, 2019, according to the sequential manner in which they are drawn.

## Prize Winner Notification

All winners will be notified in writing by Deloitte LLP as to what they have won and where to claim their prizes. All prizes must be accepted as awarded with no cash equivalencies available except as specified. Prizes awarded may not be exactly as illustrated.
